Payment

Golf

Transferable membership cards are required at all times whilst on course
All members or guests of members using the card and facilities are fully responsible for their actions

Golf Day

Corporate Golf Day includes complimentary green fees up to and including 40 players,
Monday – Thursday, March - August inclusive. All catering and hire equipment is additional cost

Boardroom Usage

Complimentary use of the Boardroom is subject to availability and requires booking
Boardroom usage can be used as one event in larger function room. Discuss the options with us

Corporate Accommodation

Accommodation bookings are subject to availability. Excluding public & school holidays, long weekends & special events as outlined by the resort.

Pro Rata Conditions

Corporate Golf Day

Gift Pack (Eagle only)

Rules & Regulations

The All Seasons Sanctuary Golf Resort Rules & Regulations MUST be adhered to at all times, see below:

Beverages: All beverages consumed on the course must be purchased from the Resort.

Attire: The correct attire must be adhered to whilst playing on the golf course. Golf shoes and joggers are the only acceptable footwear. A neat and tidy presentation is expected at all times. Examples of non conforming attire include thongs, singlets, bike shorts, football shorts/socks/jumpers, swimming apparel, work boots and bare feet.

Bad Language: Under no circumstances will bad or abusive behaviour be accepted e.g. swearing.

Golf clubs: Sharing golf clubs is not permitted. Each player is to have their own set of clubs.

Group Numbers: A maximum of 4 people in each group.

Motorised carts: Credit card details or a \$200.00 deposit is required for hire of motorised carts within a group booking. Any damages to carts used by individuals in your group will be charged at the social club members cost. Motorised carts are not to be used as "Drinks buggies", and are not to be driven while under the influence of alcohol.

Damages: Any damage to equipment, carts, The Sanctuary Golf Resort or the surrounding Golf Estate Housing is the responsibility of your group.
